### SERVICES FOR - SUBCONTRACTORS - SUPPLIERS - AND TRADESPEOPLE (Michigan Only)

#### DESCRIPTION OF SERVICES

1. **REQUEST FOR NOTICE OF COMMENCEMENT:** process the request for notice of commencement in accordance with the Construction Lien Act: *(this cost may be recoverable from the fee owner, if not received)*
2. **NOTICE OF FURNISHING:** prepare and serve notices as required by Michigan Lien Law to owners and parties of interest, to protect your payment and construction lien rights.

#### A NOTICE OF FURNISHING IS REQUIRED FOR CONTRACTORS, SUB CONTRACTORS & SUPPLIERS TO FILE A CLAIM OF LIEN IF NOT WORKING FOR AN OWNER

3. **CLAIM OF LIEN and/or MECHANICS LIENS:** (privately owned real estate) prepare all documents with a notarized proof, record at the county register of deeds with all required notices and documentation, county recording fees. Certified and regular mailings are extra, and will be invoiced accordingly.
4. **LEGAL DESCRIPTION SEARCH:** when it becomes necessary to search for the legal property identification description and/or to find the owner, designee, and/or mortgage company.
5. **BOND NOTICE OR BOND LIEN ON AVAILABLE FUNDS:** serve the pre-lien notification to the owner, general contractor, bond company and other necessary parties to preserve your payment rights under said public and private bonds for: *(city, state, schools, municipalities and government job sites; as required)*
6. **MILLER ACT/BOND NOTICE:** all required notifications to bonding companies to protect your interest on federal jobs if you work or supply material and/or labor: *(federal job site)*
7. **DISCHARGE OF LIEN AND RELEASES:** *(prepare and record document for discharge)*
8. **RUSH SERVICE:** *(7) day maximum)*
9. **SAME DAY SERVICE:** *(24) hour turn around)*
10. **DOCUMENT DELIVERY CHARGE:** *(unlimited documents per trip for same county and customer)*
11. **ALL RECORDING FEES PER COUNTY FEE SCHEDULE:** *(includes State of Michigan Remuneration fee)*

#### SERVICES FOR - OWNERS - BUILDERS - CONSTRUCTION MANAGERS

12. **NOTICE OF COMMENCEMENT KIT INCLUDES:** 3 recorded and laminated notice of commencement certificates plus 3 packs of 25 each, blank notice of furnishing, one pack 25 each of sworn statement, partial conditional / unconditional waivers / full conditional and unconditional waivers.  
*Instructions and additional copies of commencement, notice of furnishing and waivers are part of the binder kit.*
- 12a. **MCPA named as designee for job sites under \$450,000:** *(see price list, owner may specify designee)*
- 12b. **MCPA named as designee for job sites over \$450,000:** *(see price list, owner may specify designee)*
